FAQ: What am I picking up?

Riders are picking up their assigned Ride Bib# that you are REQUIRED to wear on your back to participate in the ride along with wristbands, parking pass and Nike Goody Bag filled with perks! Those that earned “Fighter” Fundraising Jersey or pre-purchased event merchandise purchased by August 15th will also pick up their items at this time.

Volunteers are picking up their event t-shirts, parking pass and volunteer instructions.

FAQ: Can I pick up others Packets?

Yes, you may pick up others' packets. However, you will need to bring the release form signed document from the person you are picking up a packet for with a copy of their photo ID giving you permission to do so and accepting all liability to ride in the ride.
